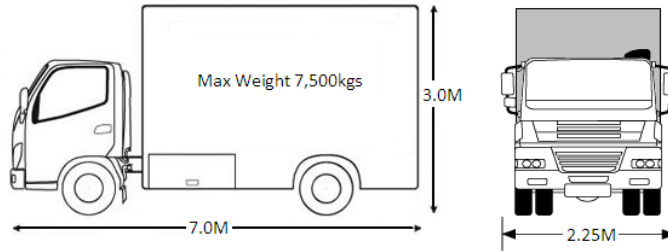


Qualifying Vehicle Criteria:
